This report summarizes the results of the **Fall/Winter Clean City ratings**.

These were the results, averaged for the city:

Location	% Clean	% Moderately Clean	% Dirty	% Hazardous
Streets	73.66	22.26	3.68	0.40
Alleys	68.34	24.01	6.60	1.06
16 Corridors	83.33	16.67	0.00	0.00

The DPW Scorecard has a standard requiring 85% of the residential streets and alleys to achieve a Clean City rating of 1 (Clean) or 2 (Moderately Clean).

Overall, we achieved a rating of **95.92%** for Streets (rated as Clean or Moderately Clean); **92.35%** for Alleys (rated as Clean or Moderately Clean), and **100.00%** for Corridors (rated as Clean or Moderately Clean). This is a combined District wide average of 97.45%.

The Clean City Ratings are 1 through 4. Clean is rated as (1), Moderately clean is rated as (2), Dirty is rated as (3) and Immediate Attention is needed is rated as (4).

FALL/WINTER Summary

RECCOMENDATIONS

An ordinance and a campaign to require residents to comply with an “alternate side of street parking” during a snow emergency. Most Washington D.C. neighborhood streets are small and narrow which does not allow for a heavy plow to shovel streets. An alternate side of street parking would require on odd-numbered days of the month, parking is permitted only on the odd-numbered side of the street. Likewise, parking is permitted only on the even-numbered side of the street on even-numbered days. Additionally, there should be a transition time between the first and second day of a snow emergency.

Require businesses and property owners to shovel snow from wheelchair ramps.

Coordinate with Metro, DPW, and DDOT to remove snow from around bus stops.

Trash truck sanitation workers need to replace trash/litter cans as found after emptying them.

Signage for litter receptacles: Not to be used for residential or commercial waste

Look into bringing Big Belly trash compactors into high density communities.

The Spring 2010 Clean City ratings are now being planned.
